ICOI has created this privacy statement ("Privacy Policy") in order to demonstrate our firm commitment to your privacy. This Privacy Policy is designed to help you understand the type of information we may collect from our users ("users", "you", or "your") who visit our website, what we do with that information, and explains the policies put in place and used by ICOI to protect your privacy as you visit and use the website, www.icoi.org and associated sub-domains. Your use of the ICOI website constitutes an acceptance of our User Agreement and Privacy Policy. Your use of any services offered by ICOI further constitutes acceptance of our User Agreement and Privacy Policy. The ICOI may change this policy from time to time, therefore, we encourage you to review the Privacy Policy periodically and to make note of the date our Privacy Policy has most recently been revised.

#### **Information We Collect.**

In some areas of our website, ICOI, requests or may request that you provide personally identifiable information, including your name, address, e-mail address, telephone number, username[s], credit card number, billing information and any other information from which your identity is discernible. We also collect non-personally identifiable information through this website to learn more about how our visitors use this website and to measure areas of interest. This allows us to build features and functionality that will enhance your experience. Personally identifiable information may be collected when you register on our website for free offers and other information that we provide to our users. Non-personally identifiable information is collected using General Tracking Information and Click Path Tracking (cookie technology). This data is in no way associated with your personally identifiable information.

Except as provided below, the information collected by ICOI is "aggregated", meaning that the information from many users is grouped together in a way that does not disclose the personal information

of any particular user. ICOI will not disclose any personally identifiable information about any individual without the individual's consent, except to comply with applicable law or valid legal process. We are not limited in our use of non-identifiable aggregate information about our users (such as the number of users of our services, the geographic distribution of our users, the amount of information located and/or removed, etc).

## Use of Non-Personally Identifiable Information.

#### **General Tracking Information.**

We keep track of the pages visited by each user. Our web server automatically collects some information about you when you request pages from our server, including your IP address. Your IP address is a number that is used by computers connected to the Internet to identify your computer so that data (such as the web pages you request) can be sent to you. We aggregate this data with data on the pages visited by other users to track overall visitor traffic patterns. We use this information to improve our website by making it more responsive to the needs and preferences of our users. This information does not identify you personally.

### Click Path Tracking.

"Cookies" are pieces of information that are placed on an individual's computer hard drive to enable the individual to more easily communicate and interact with our website. Using cookie technology, we track your click path through our website. Though this information does not identify you personally, we may use it to help customize your visit to our website. We may also use cookies to record how many times a user has visited our website and what pages the user has accessed. You may, however, disallow receiving cookies at any time through your web browser. It is not our intention to use cookies to retrieve information that is unrelated to our Site or your interaction with our Site.

### What we do with the Personally Identifiable Information We Collect.

The ICOI, its subsidiaries and affiliates may use your contact information to alert you to new information, products and services, events and other opportunities. From time to time, we may also make your contact information (but not your e-mail address) available to other reputable organizations whose products or services we think you might find interesting. The ICOI maintains a directory of members that includes your contact information. This directory, containing information about ICOI members, is publicly accessible on icoi.org.

## Right to Opt-in and Opt-out.

When you become a member or if you provide personally identifiable information in response to a special offer on our website, you are consenting to "opt-in" to receive future communications from us for direct marketing purposes. We may use your contact information to send you special promotional offers, e-mails about new features and services provided by ICOI members and their business partners, and website updates.

You also are given the right at these times to "opt-out" by locating and clicking on the appropriate box indicating that you decline such communications.
